



## MEMORANDUM OF UNDERSTANDING

### Between

Higher Education Institution from Aydın, Türkiye AYDIN ADNAN MENDERES UNIVERSITY

And

Higher Education Institution from Iran
FERDOWSI UNIVERSITY OF MASHHAD

Recognising the mutual benefits to be gained through a cooperative program promoting scholarly activities and international understanding, Aydın Adnan Menderes University(ADU), represented by Prof. Dr. Osman Selçuk ALDEMİR, Rector, and Ferdowsi University of Mashhad(FUM), represented by Dr. Ahad Zabett, Rector, shall enter into this Memorandum of Agreement and agree to the following:

### 1. ACTIVITIES

Within the framework of the enforced regulations in each of the institutions and subject to the availability of resources, with the following terms and conditions:

- 1) Establishing and developing relationships based on mutual agreement of the Parties in developing a proper strategy for exchanging and accepting undergraduate (Bachelor's) and post-graduate (Master's and Ph.D.) students and post-doctoral positions;
- 2) Creating opportunities for mutual supervision of scientific research, including Master's theses and Ph.D. dissertations between faculty members lecturers of both Parties;
- 3) Exchanging academic members, lecturers and researchers for presenting speech, developing skills, student courses, participation in scientific events such as conferences, seminars, meeting and discussions;
- 4) Forming common research groups between both Parties for performing the following scientific missions:
  - Exchanging experiences, skills, capabilities and information in entirety of scientific fields;
  - Organizing workshops for students and professors;

### 2. PROGRAM COORDINATION

Each institution will nominate a program coordinator to ensure that research and study proceed according to a reasonable schematic plan and to ensure that the terms of exchange programs are carried out. Each institution may name a successor to, or a replacement of, its coordinator. Each program coordinator will ensure that the partner institutions have all the information necessary for the promotion of the program.

Both institutions agree to keep in regular contact through their respective at the international offices and to report on progress or other specific information as requested.

# 3. STUDENT, PROFESSOR, AND STAFF EXCHANGE

- a. Each institution shall select candidates for the exchange from its own institution according to published criteria and procedures.
- b. Each institution reserves the right to approve the candidates proposed for the exchange by the other institution.
- c. The sending institution shall provide information about academic performance and ensure that visiting students have sufficient language proficiency for successful academic and social adjustment.
- d. It is expected that, on average, an approximately equal number of candidates from each institution shall participate in each exchange.
- e. Candidates from both institutions shall register in their institution of origin but enjoy all the privileges granted to candidates at the host institution.
- f. Candidates from both institutions must have their subject selection approved by their home institution and the appropriate academic authority in order to obtain the transferce of credit points.
- g. All arrangements shall be negotiated in each case between the individual candidate and the exchange program coordinator at the home institution.
- h. Candidates shall be responsible for their own travel, books, and subsistence expenses.
- i. Visiting students of the guest universities shall not be charged tuition fees by the host institution.
- j. Each institution shall require that its candidates have adequate health insurance coverage according to the requirements of the host country.

### 4. FINANCIAL MATTERS and INSURANCE

The exchange will be financed as follows:

Each student will pay his/her regular tuition and fees to the home organization. All travel costs will be the responsibility of the individual participants. Miscellaneous fees such as special course fees, key deposits, books, etc., will be paid directly by each participant.

Both institutions accepting the exchanged staff will provide:

· A program of short visits,

The cost and expenses to be paid in relation to any co-operation or collaboration envisaged under this Agreement shall be subject to further detail arrangements to be agreed between the Parties when it shall arise.

The Parties consider attracting potential financial partners, including funds.

Each participant will pay for his/her own health and accident (liability) insurance. Both organizations will require participants to purchase the insurance policy to ensure adequate coverage. Proof of adequate insurance coverage must be provided to the international office of each organization.

#### 5. DURATION AND AMENDMENT OF AGREEMENT

The Agreement enters into validity and effect on the day of its signing by the statutory representatives of the Parties. It shall be effective for a period of 5 (five) years and could be extended for subsequent periods for 5 (five) years unless it is terminated by one of the institutions upon prior notice to the other in writing not later than 6 (six) months before the termination date

The terms of this agreement may be amended at the request of one of the parties upon mutual agreement. Any amendments could be open for negotiation after both of the parties sign the Agreement. The Agreement may be amended or modified by a written additional agreement, which will be an undivided part of the Memorandum that must be properly registered and signed by the representatives of two institutions.

## 6. OTHER TERMS

Both institutions agree to carry out these activities in accordance with the laws and regulations of the respective countries. Disputes, arising in accordance with the Memorandum of Agreement will be resolved by consultation and conversation between institutions.

The Agreement is prepared in English languages in four copies, two for each Party, both having the same legal force. In addition, the English original MoU is taken into consideration for translations to any other languages.
