



**MOU OF CULTURAL, EDUCATIONAL AND SCIENTIFIC COOPERATION**  
**Between**  
**Thi-Qar University**  
**And**  
**Ferdowsi University of Mashhad**

**Foreword**

Depending on the desire of Thi-Qar University, represented by Prof. Dr. Riyadh Shanta Jabur and Ferdowsi University of Mashhad, represented by Prof. Mohammad Kafi To establish a joint Memorandum of Understanding, both parties agreed the following:

**Article 1**

Within the fields of study to be mutually designated, both institutions agree to the following forms of cooperation:

1. Joint research activities;
2. Exchange of invitations to scholars (faculty, research personnel) for lectures, visits and sharing of experiences;
3. Exchange of students for a period of study and / or research;
4. Exchange of administrative personnel for sharing of experiences;
5. Exchange of invitations to scholars for participation in conferences, symposia and seminars;
6. Exchange of information in fields of interest to both parties;
7. Exchange of faculty and research personnel for study and research;
8. Exchange of academic materials of mutual interest such as scholarly publications and curriculum information and pertinent research reports;
9. Sponsored, and/or jointly sponsored, activities such as study abroad classes and lectures, or scholarly symposia by any party

**Article 2**

Cooperation may concern all fields of academic endeavor and will be specified in a written action plan between the concerned departments/faculties of both universities. The precise program of teaching and / or research, together with financial conditions, should be defined before the arrival of participants at the host university. Specific issues related to student exchange shall be incorporated in a separate document devoted to exchanges.

**Article 3**

Both parties shall comply with any acts, enactment relating to the operation and conduct of the activities and other regulations, directions or instructions given by any authority competent to do so.

**Article 4**

Cooperation in specific areas may be designated by mutual consent and incorporated as addenda to this agreement upon signature by appropriate representatives of the two parties.

**Article 5**

This article will become effective from the date of its signature by the related parties and will remain in force for five (5) years. It is extensible automatically unless one related party submit a written notification of its termination six (6) months prior to its end.

**Article 6**

Either party shall have the right to terminate this Agreement by giving written notice if the latter commits any breach of what is provided on this MOU and it doesn't fix the defect despite its notification by writing.

**Article 7**

Either party shall have the right to amend this MOU. Such amendment will be written and signed by both parties.

**Article 8**

Both parties shall protect the rights of intellectual property for information and joint researches.

**Article 9**

MoU written in originals and two copies in Arabic, and English languages and two authoritative legal one to rely on English in the event of a dispute over the interpretation, which agree with the MoU laws.

**Article 10**

Both parties have agreed to do the procedures of visa for each other .

**Article 11**
