- **1-** *Guest Academic Member:* A scholar residing abroad who is serving as a faculty member, researcher or specialist in one of the universities, research institutes or research centres abroad, who can cooperate in be in the fields of academic, research, and technology as well as counselling on an honorary basis for the university.
- **2-** *Collaboration as a Teaching-Research Scholar*: A scholar residing abroad who works as a faculty member, researcher or specialist in one of the universities, research institutes or research centres abroad, who can cooperate in academic, research, and technology fields in the framework of a mutual agreement.
- **3-** Adjunct Academic Member: An academic individual residing abroad who serves as a faculty member, researcher or specialist in one of the universities, research institutes or research centres abroad, who can cooperate in the fields of academic, technology, and research as well as consulting in the form of a contract between the University after the approval of the Executive Board of Faculty Member Recruitment and the University Board of Directors.
- **4-** *Honorary Academic Member*: A distinguished and eminent scholar residing abroad who is serving as a faculty member, researcher or specialist in one of the universities, research institutes or research centres abroad, who can cooperate in be in the fields of academic, research, and technology as well as counselling for the university.

Notes:

- 1: For all the above cases, it is necessary to obtain the consent of the Vice-Presidency for Academic Affairs and/or the Vice-Presidency for Research and Technology of the University as per the nature of the cooperation.
- **2**: For all the above cases, a notification letter of cooperation will be issued by the Secretary of University Board of Faculty Member Recruitment.
- **3**: For all the above cases, the duration of attendance at Ferdowsi University of Mashhad is determined based on the agreement of the parties.
